

## Local School Nature Grants Phase 10 Terms and Conditions

- I confirm that I have support from my setting's leadership team to apply to this programme.
- I confirm that the setting I have applied for has not received a Local School Nature Grants award previously.
- If successful, we will commit at least 5 members of staff to partake in the training element of the programme. LtL will, where we can, visit your setting to deliver the session.
- I understand that the trainer allocated to our setting will be travelling to our site to deliver our training session and as such any cancellation or rescheduling will have a cost implication. Please give careful consideration when choosing your training date so this can be avoided.
- Timing of training is typically AM 9am to 11am or PM 1pm to 3pm or Twilight 4pm to 6pm however there is the possibility, in discussion with your trainer, of changing timings to suit. E.g. starting a twilight session at 3.15pm or 3.30pm.
- Cancellation must be made in writing within 7 working days prior to the confirmed date of delivery. None attendance, strike action or school disorganisation also does not constitute a cancellation.
- It's important that all aspects of the award can be enjoyed by the setting. I understand that in the very unlikely event that a mutually convenient date for training is unable to be set that the setting may be liable for the cost of the products chosen.
- If successful the setting consents to displaying a plaque marking their participation in the project. This is provided free of charge.
- LtL aim for the training session to be very practical and interactive. I understand that some kneeling or sitting on the ground maybe required during the training session. We will aim to be outside for the whole session, weather depending.
- If successful, the school will co-operate with Learning through Landscapes, People's Postcode Lottery and their funding trusts (either People's Postcode Trust, Postcode Neighbourhood Trust, Postcode Places Trust, Postcode Society Trust, Postcode Local Trust or Postcode Community Trust) to evaluate and publicise the programme in relevant media, perhaps through a case study or other press involvement. I agree to the signing of permission forms in this instance. I also agree to being contacted with future offers from Learning through Landscapes.
